Planting the seeds for growth

Headquartered near Nice, France, Arkopharma Pharmaceutical Laboratories SA specializes in phytotherapy, leading the European market with products sold in more than 60 countries around the world. The firm is dedicated to helping consumers improve their health and well-being using natural medicines and dietary supplements. In pursuing new product formulas, Arkopharma has been awarded 1,621 product registrations and marketing authorizations (MAs). It also invests 4% of its revenues in research and development.

To support its product development, manufacturing, and distribution efforts, Arkopharma deployed the SAP® ERP application in 2003. Over the years, the company developed many new products and expanded its customer base with the help of the SAP software. These projects were conducted and documented by the company's SAP-certified center of expertise, using methodology supported by the ASAP methodology for upgrades.

To take advantage of new software functionality, Arkopharma management recently decided to upgrade its SAP ERP implementation. Because the



software is so integral to corporate operations, the company's upgrade had to be executed with minimal delay or disruption.

"To streamline the update process, we wanted to map and document our IT processes in a centralized location," explains Virginie Baesberg, information management director of Arkopharma. "Improving our test management and closely tracking our testing processes were also critical to a successful upgrade."

Formula for high-quality testing

In planning its SAP ERP upgrade, members of the Arkopharma center of expertise worked closely with experts from the SAP Active Global Support (SAP AGS) organization to determine best practices and next steps. The team decided to use SAP Solution Manager to support the company's upgrade.

"SAP Solution Manager helped us centralize and harmonize our process definitions for both SAP and non-SAP software," explains Alain Giraud, CIO of Arkopharma. "We documented those processes, which allowed us to better manage and share information. Any changes to the software can be identified accurately and quickly."

Arkopharma also used SAP Solution Manager to build and update test plans. Personnel monitored tests in real time and tracked open incidents. In addition, the tool helped the company identify critical processes necessary to support quality regulations, such as Good Manufacturing Practice, Good Distribution Practice, ISO 22000 and 13485, and Ecocert. Using SAP Solution Manager, the firm conducted risk analyses and generated acceptance reports.

"SAP Solution Manager quickly became the cornerstone of our quality processes," says Giraud. "With enhanced visibility into the impact of changes made to the IT system, the upgrade was completed on time and within budget."

Arkopharma conducted the upgrade in phases, supported by consultants from SAP AGS. The strong support from center of expertise personnel, in addition to the team's mastery of company processes, helped the project succeed.
